# HOW IT WORKS

MedDraft allows patients and providers to establish a secure automated payment plan using a checking account or major credit card. MedDraft manages the process on behalf of the provider and makes it easy for patients to maintain financial oversight through our patient portal.

Setting up your MedDraft payment plan is simple. You can sign up in person at your provider's office or authorize your payment plan by phone.

If you would like to apply in person, your medical provider will prepare and submit your application on your behalf. All you will need to do is have your checking account or credit card information available.

If you would like to verify and authorize your payment plan by phone, please contact your provider or their billing office. Your provider will then submit your application online and you may call in to verify and authorize the payment plan.

- A major debit or credit; or a checking account
- Your signed application or verification by phone
- An active email address

## IN PERSON

- Your provider will present you with an out of pocket estimate
- Complete and sign your application
- Your provider will approve and submit the application to MedDraft on your behalf
- MedDraft will automatically debit payments from your checking or credit card account

## BY PHONE

**MedDraft is not a finance company.** MedDraft manages payment plans and is used by providers to offer patients a short-term zero interest pay-plan extension.

**Contact Policy** By providing contact information, patients authorize MedDraft and/or third party agents to contact them via means necessary to communicate information regarding their account. Communications include but are not limited to automated voice messaging, cell phone, text, email, voicemails and autodialing devices. Communications may include the name of the medical provider and/or MedDraft.

**Terms and Conditions** If there are any changes to your coverage resulting to a change in your balance owed, you will be notified by your provider. Any default in terms will result in termination of the payment plan and the balance in full will be due. Accounts may be forwarded to a third party collection agency for follow up. Patients are responsible for any collection and/or attorney costs associated in connection with collecting the balance.
